EXERCISE OF OPTIONS

Collaborate Corporation Limited (ASX:CL8) (**Collaborate** or the **Company**) advises that the Company has today issued 15,567 fully paid ordinary shares (**Shares**) upon the exercise of unquoted options exercisable at \$0.015 per option and expiring on 18 December 2020.

Additionally, the Company has today issued 706,009 Shares upon the exercise of unquoted employee options exercisable at \$0.01 per option on or before 2 September 2022. Together, the option conversions raised \$7,294 before costs.
